



Directions to the Council on Chemical Abuse

From Lancaster County:

Follow 222N to Reading. Take 422 E/Pottstown Exit. Follow 422 E. Take Penn Street/Reading Exit.

Follow Penn Street straight to 6th Street. Turn left onto 6th Street. Go one block and turn right onto Court Street. You will see a parking garage on your right. Park there.

Take elevator to lower level. Exit into courtyard. We are in the Santander Bank building on the 6th floor, Suite 600.

From Lebanon County:

Go east on Route 422. After you leave the town of West Lawn, Route 422 will split. Bear left onto the exit for Penn Avenue, and go over the bridge. Follow this road straight. You will enter the town of Wyomissing and then proceed into West Reading.

Go all the way through Wyomissing/West Reading (approximately 14 lights or so). Leaving West Reading you will see the Penn View Hotel on your right and then go under a railroad bridge. Going straight over bridge into Reading.

Follow Penn Street straight to 6th Street. Turn left onto 6th Street. Go one block and turn right onto Court Street. You will see a parking garage on your right. Park there.

Take elevator to lower level. Exit into courtyard. We are in the Santander Bank building on the 6th floor, Suite 600.

From Harrisburg:

Follow Route 83 South to the PA Turnpike. Take the PA Turnpike East toward Philadelphia/Exits 20-39.

Take exit 21 off the turnpike and then take the 222N ramp towards Reading. Follow 222N to Reading. Take 422 E/Pottstown Exit. Follow 422 E. Take Penn Street/Reading Exit.

Follow Penn Street straight to 6th Street. Turn left onto 6th Street. Go one block and turn right onto Court Street. You will see a parking garage on your right. Park there.

Take elevator to lower level. Exit into courtyard. We are in the Santander Bank building on the 6th floor, Suite 600.

From Allentown:

Follow 222 South to Reading, passing through Kutztown and Temple. Continue on 222 South/Reading. Take Penn Street/Reading Exit.

Follow Penn Street straight to 6th Street. Turn left onto 6th Street. Go one block and turn right onto Court Street. You will see a parking garage on your right. Park there.

Take elevator to lower level. Exit into courtyard. We are in the Santander Bank building on the 6th floor, Suite 600.

From West Chester:

Take Route 100 North towards Exton. Follow 100 North to Route 422 West (near Coventry Mall).

Follow Route 422 to Reading. Route 422 will split after you pass a Best Western Motel with the Antique Airplane Restaurant on your right. Bear to the left to go towards Reading on 422 bypass.

Take the Penn Street exit-the first exit. Come off the exit and follow Penn Street into Reading to 6th Street. Turn left onto 6th Street. Go one block and turn right onto Court Street. You will see a parking garage on the right. Park there.

Take elevator to lower level. Exit into courtyard. We are in the Santander Bank building on the 6th floor, Suite 600.
